In case of Default of Payment as per "clause g", We, M/s Furniture & Interior Rental Pvt Ltd shall be entitled to terminate this Hire Agreement and Forfeit the Security Deposit without any further notice to the Client and the Client agrees to handover the peaceful possession of the rented goods & clears the complete payment as per the agreement.

M/s Furniture & Interior Rental Pvt Ltd is not liable for any accidents/ mishaps/ damages / losses etc suffered by the client &/or clients' guests & /or any other third party due to use (or otherwise) of goods supplied on rent by the company. - j. Minimum one week notice is required before return of Material
- k. Any Variation in Govt. duties & taxes will be charged as actual
